**Subject matter of the procurement:** the right to conclude a contract for rendering consulting services in Chile.

**Subject matter of the contract:** rendering consulting services in Chile.

**The initial (maximum) contract price:** 45 600,00 EUR including VAT and all applicable taxes.

**Time frames for provision services:** in accordance with the Part 3 “Draft Contract” of Volume 1 of the Procurement Documentation.

**Place of provision of services:** in accordance with the Part 3 “Draft Contract” of Volume 1 of the Procurement Documentation.
